Pastor's Report

Therefore, go and make disciples of all the nations, baptizing them in the name of the Father and the Son and the Holy Spirit. ²⁰ Teach these new disciples to obey all the commands I have given you. And be sure of this: I am with you always, even to the end of the age." (Matthew 28:19-20 NLT)

These verses represent the marching orders of our commander and chief the LORD Jesus Christ. The task of making disciples from people of every tongue, tribe and nation is the main purpose of the local church. A disciple is someone who is a learner and they learn by following Jesus. So, the task of any true NT church and the task of Grand River Community Church is to guide people to trust in the LORD Jesus Christ and then to grow in Him, so that they might be thrust out into this world to go and make more disciples. In other words, GRCC should exist for mission. Everything we do should have a part in fulfilling this mission. As we concluded our 19th year and head into our 20th, our Elders are looking at reworking our vision statement to something like this: *GRCC exists to glorify God by making and maturing disciples, who are together becoming like Jesus Christ and fulfilling his mission.* Please pray for me and our Elder team as we work with you to determine if this would be a good change to our vision statement. Pray as well as we reflect and develop a strategy to ensure that by God's grace we are working towards seeing this vision become more of a reality.

Worshipping on Sundays when we sing praises to God, talking to Him through prayer and listening to His Word should be for the purpose of building us up in Christ and/or calling those who don't believe in Christ. As we go out from our Sunday worship, we should be going as an empowered and unified mobile missionary force to encounter intentionally as many people as we can with the Good News of the Gospel. Throughout the week when we meet in Small Groups, we should meet with the dual purpose of growing in Christ as we encourage each other and being trained to bring the Gospel to our community. As we interact with each other in fellowship, it should be with the purpose of sharing in Christ, building each other up, spurring each other on to acts of love and carrying the Gospel to our community.

From where I sit, 2016 was a year of both blessings and struggle where we saw some growth in some area of ministry and decline in other areas. Some of our outreach ministries have experienced some growth (See outreach report). Our Sunday morning attendance continues to go up and down. We hope that by engaging more people in ministry it will help those who attend to be more invested and have a greater desire to make their attendance more regular.

Our Coordinator/Deacons serve faithfully in their areas of ministry. In worship Sandra Toman and Kyle Bott have worked diligently with our musicians and singers to help guide us in worship. The desire and need is for more participants in that vital ministry. Amy Hauer has helped to plan some wonderful events and create opportunities for us to be together as a church family. Ruth Robinson has worked to help lead our Small Group leaders in their ministries. In 2015, while we had a similar number of small groups the number of people who participated declined some. Our prayer coordinators Amy Bott and Laura Barnes have set up a new email prayer chain and have reorganized the phone prayer chain. They had encouraged prayer within the church and added a Sunday morning prayer time on communion Sundays. As a congregation, corporate and individual prayer is an area that we should be engaging in more diligently as a congregation, and so I'm grateful that God has provided the leadership of Amy and Laura to continue help us. Carol Gerrie skillfully and faithfully served as our treasurer for the first part of 2016 and then

has taken a break from this ministry after eight year of sacrificial service. Terry Thompson and Carl Harris took over the treasurer responsibility in the fall of 2016 and are doing an excellent job. Thank you to all who faithfully contributed financially as we came very close to meeting our 2016 operating budget even though we raised it by faith.

Preaching and teaching remains a significant part of my ministry and I am thankful for the opportunity to participate in that ministry in our Worship Services, Query and teaching a Small Group. Query is our interactive adult class that meets on Sundays from 9:00-9:40 a.m. In 2016, we continued a course that examines both the Chronology and the Theology of the person and work of the LORD Jesus Christ. We took a break from Query in the summer and it was the decision of our Elder leadership team to stop Query for the rest of 2016 with a plan to replace it with a bi-monthly teaching/discussion time that will be proceeded by an optional casual potluck meal fellowship.

Sunday morning sermons in 2016 consisted of an exposition of the book of 1 Corinthians called "THE FOOL'S GUIDE TO THE LOCAL CHURCH". That series took the entire year and into January of 2017 to complete. My hope and prayer is that the preaching/teaching have challenged you and that God the Holy Spirit has used them to produce growth in your life.

Our Elders met together regularly for prayer and ministry planning. We are working towards becoming incorporated. The Elders fully recognize that we are responsible for the spiritual direction of GRCC and so we continue the process of looking at our vision statement to make changes that will help to clarify the direction in which we believe God wants us to go. We want to have more than a statement. Relying on the LORD for direction, we desire to come up with a strategic plan that will help us be more intentional in our ministry. We believe God wants us to train the disciples who attend GRCC so that we might be more effective in reaching into Centre Wellington with the goal of carrying the Gospel in word and deed and as God works through us, making more disciples for him. Our upcoming Sunday evening fellowship and study is designed to ultimately begin to address this more directly.

Outreach Report

"Love your neighbor as yourself..." (Mark 12:31) "Go make disciples of all nations" (Matthew 28:19) These two verses are the Biblical foundation for outreach ministry at GRCC.

- 1) We try to love those in our community by trying to meet some of their practical needs.
- 2) In a variety of ways, we try and reach out with the Good News of the Gospel of Jesus Christ.

Some of the ways that we have continued to help meet practical needs is by giving out Thanksgiving Hampers, and by actively helping those in need of assistance that God has brought in our path. In 2016, we gave Thanksgiving hampers to four needy families in our community. We were able to assist several families and especially some single moms by providing groceries or paying some bills for them. Last year, we partnered with Under the Same Sky (USS), http://underthesameskycw.org/, to help raise funds and offer support to needy refugee families that LORD willing will be relocating to Centre Wellington. This year we tried to further raise awareness through our annual Art Coffee House where we highlighted the ministry of USS and collected donations towards that ministry.

Our ministry to reach out with the Good News of Jesus continued in 2016. One of the tools we use is Christianity Explored (CE), where people come and enjoy a meal each night as they work through the Gospel of Mark. They learn the basics of who Jesus is, why He came and what it means to follow Him. This spring with the launch of Onside Sports we did not host a Christianity Explored. We did not run CW at GRCC this year, but we have it as a resource that we hope will be used in various locations by groups of people from GRCC to help reach their friends and neighbors in the future

We have not been able to restart Celebrate Recovery (CR) ministry in Centre Wellington due to a lack of trained leaders but in 2016 we did have more interest and we have a potential location. As I try to move towards finishing my thesis, I need to step away from spearheading this restart and try to encourage others from GRCC and other churches to join hands in training and relaunching this ministry. Perhaps this can happen in 2017.

We continue to have some events in the year that are designed to connect with unchurched people. Our Art Coffee house was not well attended but we did have some unchurched people join us. The goal for the future is to connect with more of the artistic community in CW and encourage their participation and connect more with that demographic. We had our annual Good Friday Breakfast and our Adult Christmas Banquet as events that the unchurched were welcomed to.

Friday night floor hockey for males high school age and up has proven to be a good way to connect men from our church with those who do not know Christ yet. This meets every other Friday at present. We continue to have an average of about 8 attend with as many as 15-20 on occasion. We continue to take a 5 minute break in the middle of playing time for rest (this older guy needs it) and to present the Gospel. This is done either by me or one of the guys who attend from GRCC. All the unbelievers who attend are quite intent on listening to a brief message each time. Pray that God will help the guys from GRCC to build relationships that will allow us to share the Gospel freely.

Onside Sports ministry experienced some good growth in 2016. God blessed beyond what we were expecting with close to 150 children registered to play soccer with us on Monday nights at Elora Public

School. Onside director Bryan Gillmore continues to assist us. Our Pastoral Intern Jamie Hauer serves as our commissioner. Jamie had a team of convenors, Fields and Equipment (Jesse & Ali Booker), Spiritual (Amy Bott) and Food (Laura Toman) who all did an excellent job. We had a wonderful team of coaches from GRCC and the community. In addition to teaching soccer skills and running a great soccer league, we had an opportunity to have an impact spiritually in two significant ways. 1) There was a team talk each week that presented some Biblical teaching on character development and presenting the Gospel in the final week. 2) The coaches from GRCC showed by their demeanor that character development was more important than winning games. Thanks to all who helped in this ministry! The one drawback in 2016 was that while our league experienced some growth our volunteer involvement did not increase and so this provided some extra stress for those who did serve. We are gearing up for the 2017 season so consider how you might help this Spring/Summer. In the summer of 2016, we ran 3 weeks of summer camp, 2 soccer and 1 ball hockey at Salem and Elora Public Schools. Then one free soccer camp week at GRCC. In our initial year attendance was less than we hoped with 26 registered for our free week at GRCC. The rest of the weeks combined we had about 50 children attend. Pastor Jamie Hauer headed up this ministry and Onside Sports provided an excellent team of High School and College students that were paid through the Summer Job CRA program and Onside Sports. This summer we are planning on running another 4 weeks of summer camp with Onside. There are opportunities to serve in that ministry as well. See Jamie Hauer for more details.

We continued to reach out beyond Centre Wellington through the missionaries we supported through prayer and financially in 2016. In 2016, support to Diane Friesan ended as she is presently working on Ph.D studies in the Micmac language. We continued to support 1) The Greths who worked in France training leaders (Feb International). Recently the Greths came back from France and are serving in Quebec and our missions committee needs to determine what support we will continue to give them. 2) The Flemmings who are planting another church in Tokyo, Japan (Feb International) 4) Karen Bast, with Youth For Christ the Door in Guelph where she serves as director. 5) The Jones' family, with Rev. Stephen Jones serving faithfully as the Fellowship of Evangelical Baptist Churches in Canada President. 6) Andrea Robinson was recently added and she has started receiving support for her work with YFC The Door in Fergus. In addition, GRCC contributed about 1% (\$1800) of our operating budget to Feb Central for their work in resourcing FEB churches in Ontario and the ministry of church planting. Our mission's committee distributed letters and information throughout 2016 to keep you informed on the work of these missionaries.

May God empower us to move out courageously to share the Good News about Jesus Christ together in 2016.

Prayer Report

We continue to be encouraged at the love our church family has for each other exemplified by prayer support. As Prayer Coordinators, we have focused our efforts in two areas of service, the email prayer chain and the Sunday morning prayer times.

The email prayer chain continues to be a source of contact for our church family members to receive prayer by the individuals who have signed up to be Prayer Partners. We had some technical difficulties partway through this year but those have been sorted out, and the prayer chain is now checked multiple times per day. The email address prayer.grcc@gmail.ca is provided weekly in the bulletin.

When we began the prayer chain sign up, we provided the opportunity for members to sign up for a phone prayer chain or the email prayer chain. Through this signup sheet we found that less people were interested in committing to the phone chain. However, the phone chain is available for anyone if email is unavailable and both our phone numbers are contact numbers that can be reached if anyone has a prayer request they would like on either prayer chains email. These numbers can be found in the bulletin.

Additionally, we wanted to provide a time of corporate prayer for our church family and to try a different format than the concert of prayers. Therefore, every Communion Sunday we meet from 9:15am – 9:45am for a time of prayer together, in the middle Sunday school room. We typically follow the pattern of prayerfully reflecting on who God is, praying for the global church, our local church, the government and we finish with a time of private individual reflection. We have a small group that regularly attends this prayer time and more people are always welcome to join! Our next scheduled dates include: February 12, March 12, April 9, May 14, and June 11.

Lastly, as we move forward, we are hoping to include an anonymous prayer request option which we are still determining how that would best be implemented. In addition, we plan to lead another "Approaching the Cross with Prayer" this Easter.

Youth

Jr. High Report

Beginning in January, we took our TNT through the Alpha Youth Film series and they were taught the fundamentals of the Christian faith in a way which relates to kids of their age. This took us to the beginning of April at which time we did a series on the book of Philippians. In this series, they witnessed Paul's love for the church and they saw that love, joy, and thankfulness are best experienced in a relationship with God. They were encouraged to think about God as the reason for why we exist and why we do anything. This series took us to the end of June where we entered the summer. The summer did not have a regular teaching schedule but in our interaction with them, we challenged them in their interaction with God during the summer. September through December, we had a series on the Old Testament where we surveyed different biblical writing styles and characters. Students saw how the Bible still applies to them.

Events that our Jr. High participated in were bowling and overnighter, LazerQuest, a night in the school gym, and an end of the year party with parents invited. They went to the movies and swimming at the Tindall's, and participated in a water night, rubber chicken night, thanksgiving baking night, Strom's Farm, Play with Clay, and a Christmas Banquet.

This year saw a big increase in students and new students which has been very encouraging. We have 17 students who attend our Jr. High program although some of this number are not regular attendees. These new students, as well as the returning ones, desperately need Jesus. We have seen times of curiosity and interest in the Bible and Jesus but no salvations. Keep praying!

There was a shift in leadership as Amy Hauer had to move to a background role and as of yet, we are still looking for a replacement female leader on Tuesday nights. Laura Toman and Ron Barnes remain invaluable in their leadership.

Sr. High Report

This year is Sr. High, we did a series on the Nature of God. We looked at various attributes of God and discussed how these make a difference in the lives of our students. We challenged our students to really think about what it means to be without such an amazing God and what it means to reject Him. This series challenged our Christian students to think critically about what they read in the Bible and what they have been taught.

Events included Hangout's at the Hauer's, a Nerf Night, Recharge winter retreat, Lazer Quest, and volunteering at Bible's for Missions. Also, an end of the year party, water night, making food for The Door, a Thanksgiving Hamper Handout, Strom's Farm, Lawn Raking, and a Christmas Banquet.

Students in our Sr. High have remained the same throughout the year. We have seen some spiritual growth in a couple of our older students but there is always room for improvement. Please pray for our students, especially those who have not come to faith!

Leadership changed in Sr. High as Amy Hauer has moved into a background role following the birth of our son. Amy Bott has graciously replaced her and I look forward to seeing her in action this new year!

We are monitoring our septic system and will have to do work on the pipes this coming summer.

We have done some maintenance on the entrance hall wooden doors. We had to replace the whole back door off the fellowship hall. The original cost of the doors and frame were \$5500, thanks to Mitch and his access to special pricing as a contractor we were able to purchase the whole new system for \$3500. Mitch kept some of the old glass from the doors and re installed it in then new doors.

I would like to acknowledge the outstanding help of Tim, Mitch, Darcy, Earl, and Doug Morat, for their time and craftsmanship on replacing the door assembly.

I would really like to thank the devotion and the enthusiasm of the Trustees, Tim (secretary), Jessie, Jeremy and Barry.

Quite frankly, they make me look good! Thanks, Guys! I respectfully present this report to the congregation of G.R.C.C. and thank you for your support.

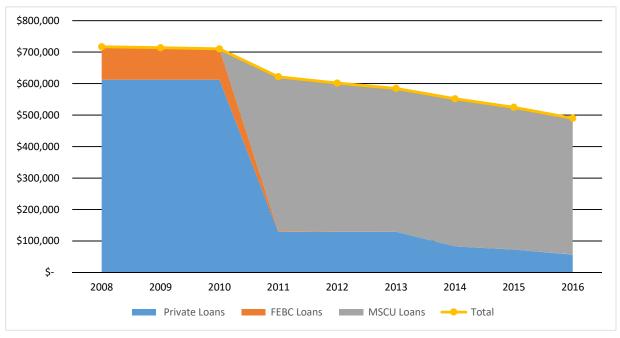
